

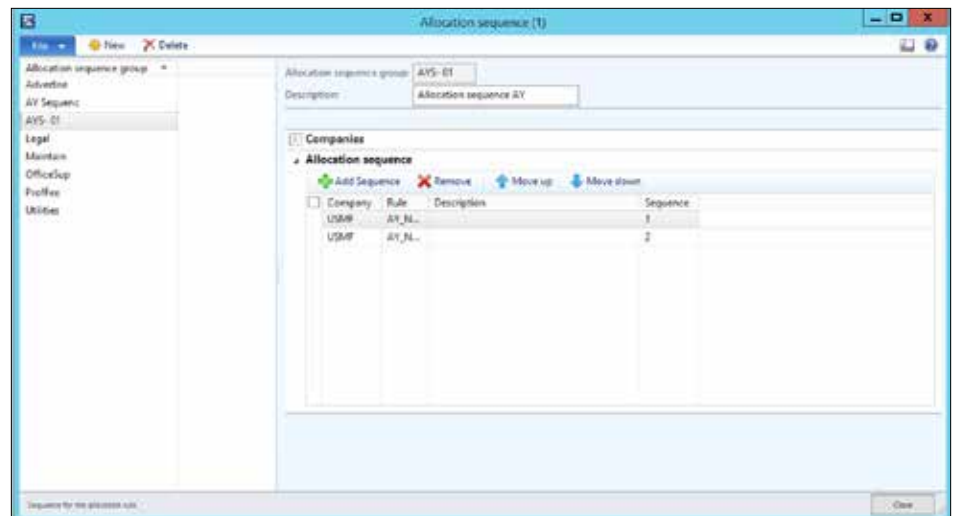

FAQs

Q: Can I create an allocation across multiple entities directly in Microsoft Dynamics AX without this app?

A: No, within AX you must manually create an allocation within each company. This app streamlines the allocation process by allowing you to create allocations for multiple companies and manage those allocations in a single screen.

Q: Can I create and schedule a sequence for specific department levels with this app?

A: Yes, you can create multiple sequences at either the company level, business unit level, or department level. These sequences can be automated, and you can manage them all within the app.

Q: When I create a new company, can I copy an allocation from an existing company?

A: Yes, once you create a new company you can copy an allocation from an existing company to your new company. The allocation in the new company can also be added to your existing sequence to allow for automatic execution.
