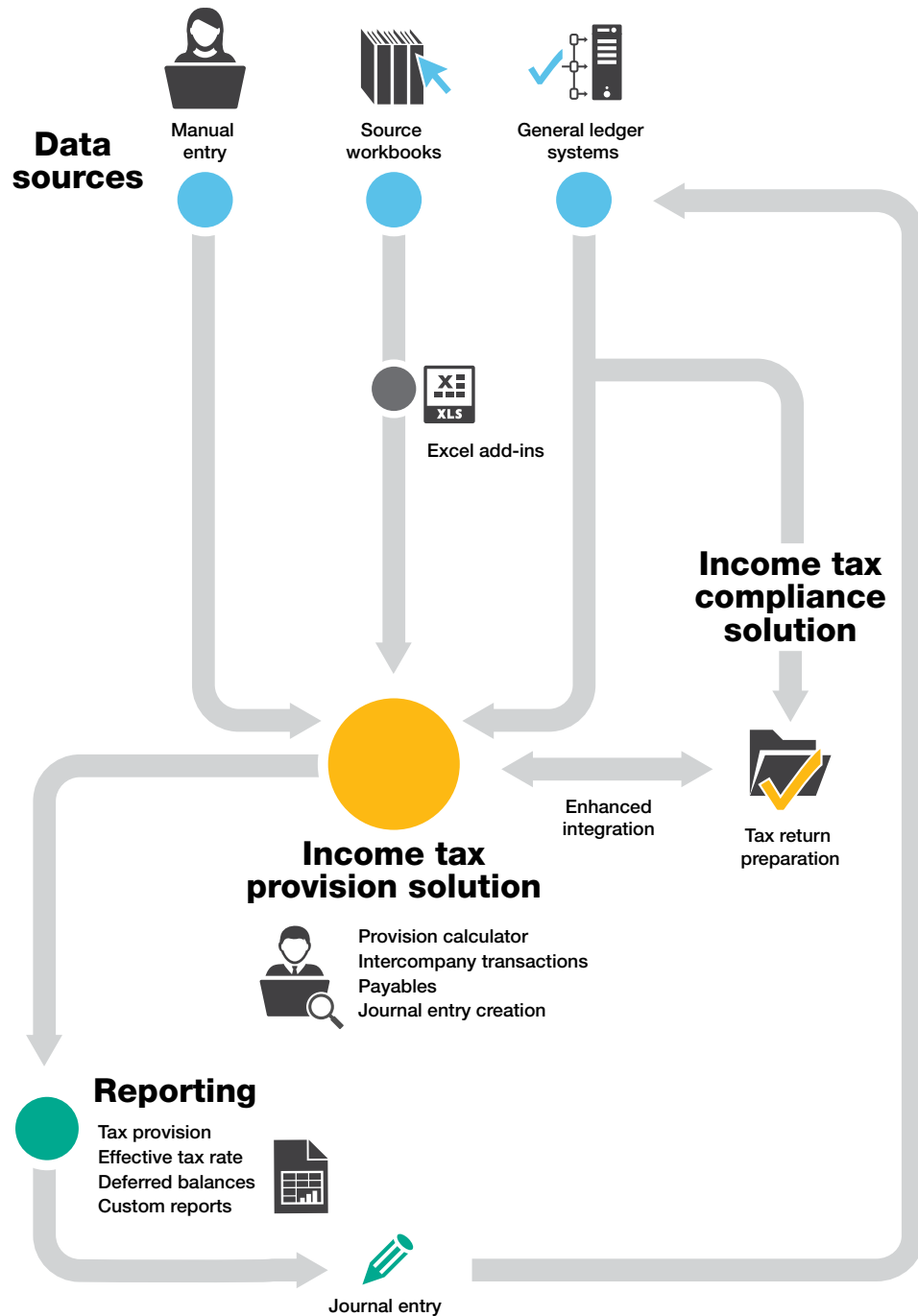
Compliance
