Scoring key

Bad debt (percent of gross patient services revenue)

Numerator: Bad debt adjustments within the current month
Denominator: GPSR generated over the current month

Cash as a percentage of 60 day lagged net revenue

Numerator: Acute cash (posted to patient accounts) collected over the month
Denominator: Net revenue generated for a one-month period, two months prior

Credit days

Numerator: Current period end credit AR
Denominator: Average daily GPSR from previous three months

Denial realization gap (uses 835 data)

Net-to-gross percent realization on non-denied accounts minus net-to-gross percent realization on initially denied accounts

DNFB days

Numerator: Accounts receivable at current balance where final bill date is null and discharge date (IP) or admit date (OP & ED) is present
Denominator: Average daily GPSR from previous three months

Initial denial rate (uses 835 data)

Numerator: Denied charges from 835 electronic remits within the current month
Denominator: GPSR from 835 electronic remits over the current month

Late charges (percent of GPSR)

Numerator: Charges added or subtracted (absolute value) to the account with post-dates greater than four days from discharge date (IP) or admit date (OP & ED) within the current month
Denominator: GPSR generated over the current month

POS cash collections (percent of patient payments)

Numerator: Patient payments within four days from discharge date (IP) or admit date (OP & ED) within the current month
Denominator: Total patient payments within the current month

Self-pay after insurance collection rate – managed care/commercial (uses 835 data)

Numerator: Sum of patient payments for managed care and commercial payers (linked to 835 remits lagged three to six months)

Denominator: Sum of patient responsibility from 835 electronic remits for managed care and commercial payers (remits lagged three to six months)

True AR days

Numerator: Total accounts receivable at current account balance (excluding credits), includes account balance plus contractual allowance if insurance payment has not posted

Denominator: Average daily GPSR from previous three months

True AR > 90

Numerator: Current period end grossed up (account balance plus contractual allowance if insurance payment has not posted) debit AR aged over 90 days from date of service

Denominator: Current period end grossed up billed debit AR

Crowe is now providing Crowe Index Scores for health systems. The scores rank overall revenue cycle performance based on weighted KPIs compared against nearly 600 U.S. hospital peers. KPIs are weighted based on impact to performance.
