Insight of the month

The initial claim denial rate for inpatient care related to prior authorization or precertification issues was up more than 30% in October compared with October 2021 and more than 50% compared with October 2020.

Tip of the month

Triage initial inpatient prior authorization and precertification denials as quickly as possible and provide the appropriate clinical support to the clinical denials team to facilitate timely appeals. And don't forget to use the denials record to monitor progress and success.
