Overview

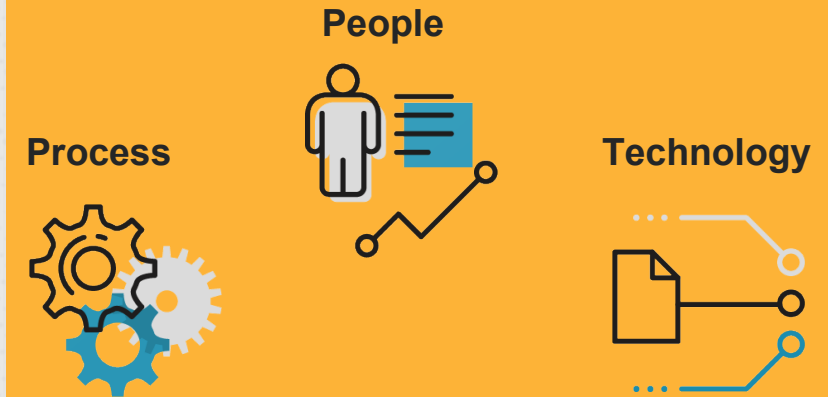
Thanks to all the participants in the 2022 TPRM benchmark survey, Crowe was able to compare the TPRM operations and activities of industry leaders. Participants were provided with a personalized report detailing Crowe’s analysis of their TPRM program, highlighting key similarities and differences between peer programs for consideration and possible improvement.

Participants were then further divided into peer groupings based on employee count and annual revenue.

Participants included Medical Device Manufacturers, Pharmaceutical Companies, Bio-Technology Firms, Contract Research Organizations (CROs), and Clinical Laboratories.

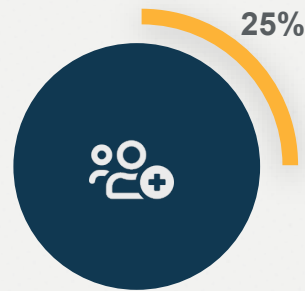
People

The driver of successful TPRM programs. Many organizations (+50% of respondents) are facing difficulties hiring and retaining employees, in a highly-desired skillset.

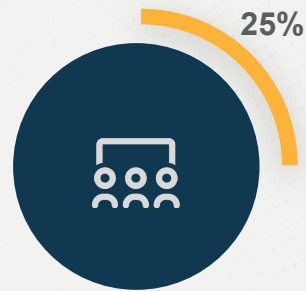


What challenges are you experiencing?

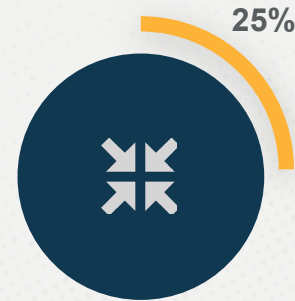
Respondents selected one or more checkboxes within the survey and the graphics below align with the percentage of respondents selecting each option. Results are sorted from least common to most common.



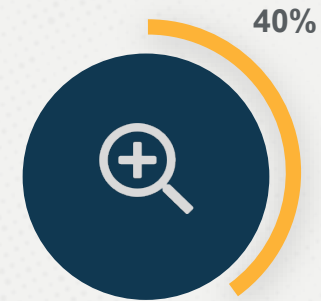

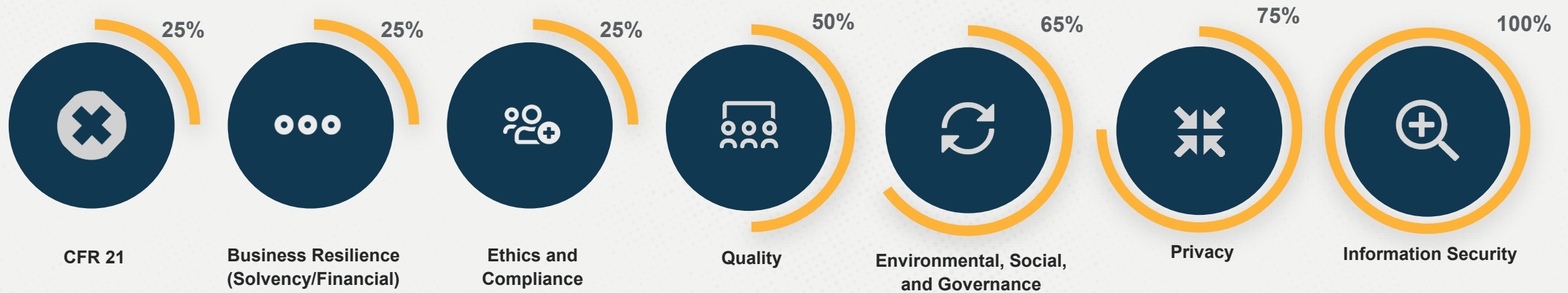
Process

What risk domains does your third-party risk program address?



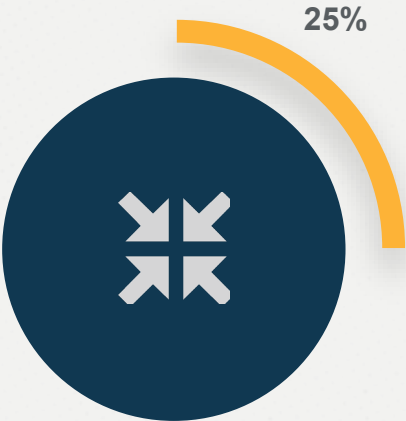
