**JUDICIAL NOTES:****Conway J. Endorsement**

The Proposal Trustee's motion for a distribution and discharge order came before me today. It is unopposed. In particular, Mr. Manis for the debtor advises that despite his efforts, he has no instructions to oppose the payment of the "Disputed Claims" in full.

The discharge order is sought because of the more active role taken by the Proposal Trustee with respect to the holding and distribution of funds. It is acceptable to me.

Mr. Manis requests that the final distribution to the debtor be made to his firm. This is consistent with prior payment orders that I have made. The Proposal Trustee does not oppose that amendment and its counsel Ms. Spence confirmed that she would not know where to send funds to the debtor in any event.
