TRUSTEE'S PRELIMINARY REPORT TO THE FIRST MEETING OF CREDITORS

DISCLAIMER:

One of the underlying principles of the Bankruptcy and Insolvency Act (the "**Act**"), is that of creditor's control. The Act provides for a First Meeting of Creditors to discuss the collective interest of the creditors in the administration of the bankrupt's estate.

The purpose of the First Meeting of Creditors is to consider the affairs of the bankrupt, affirm the appointment of the Trustee (or substitution of same), appointment of 1-5 inspectors and to give further direction to the Trustee as may be necessary.

Readers are cautioned that this report is only to provide creditors information gathered by the Trustee to date, so that their collective interests can be discussed at the First Meeting of Creditors. However, the Trustee has not audited or verified the information provided to it in anyway, unless noted otherwise.

The contents of this report should be considered "for general information purposes only" and not definitive.

INTRODUCTION

 Oasis Global Inc. (the "Company" or "Oasis") was caused to make an assignment in bankruptcy on February 15, 2024 (the "Filing Date"). Crowe Soberman Inc. ("CSI" or the "Trustee") was appointed as Licensed Insolvency Trustee of the Estate of the Bankrupt by the Official Receiver.

BACKGROUND

- 2. According to the Ontario Profile Report, the Company was incorporated under the *Ontario Business Corporation Act* on October 04, 2013. As of the Filing Date, Mark Rivers was listed as the Company's Officer.
- 3. The Company was a distributor of all-terrain vehicles, power sport vehicles, other off-roading vehicles and accessories across Canada.
- 4. The Company's head office and operations were located at 101 Rolph Road, Baltimore, Ontario (The "**Property**").

CAUSES OF INSOLVENCY

- 5. On August 31, 2023, CSI was appointed as Receiver by the Court, of all of the assets, undertakings, and properties of Oasis.
- 6. On February 15th, 2024, the Receiver caused Oasis to make an assignment in bankruptcy. Given the Company's lack of financial resources to satisfy its debts, the Receiver determined that its best course of action was to assign the Company into bankruptcy.

TRUSTEE'S ACTIONS TO DATE

- 8. The Trustee's actions from the Filing Date to the First Meeting of Creditors include, but are not limited to the following:
 - a. Notifying all known creditors of the bankruptcy on February 22, 2024;
 - Assisting creditors in filling out the proof of claim forms;
 - c. Reviewing proofs of claim filed to date;

- d. Placing a Notice of Bankruptcy in a local newspaper (The Toronto Sun) on February 28, 2024;
- e. Engaging Rise Payroll to prepare T4 tax slips for all persons that were employed by Oasis, during the year 2023;
- f. Communicating with the Company's former employees, for the purpose of calculating amounts to be claimed under the Wage Earners Protection Program Act;
- g. Working towards disclaiming the Company's lease of the Property (to be approved by the Inspectors);
- h. Listing the Property for sale and arranging for a real estate agent to conduct showings of the Property, and communicating with potential buyers;
- Updating and maintaining the Trustee's website in connection with these Insolvency Proceedings; and
- j. All other statutory duties required under the Act.

CREDITORS

i) Secured Creditors

- 9. The Trustee understands that the Company's secured creditor, Chriscwe Holdings Inc., will be filing a secured claim against the Company in the amount of approximately \$9,485,267.40 plus interest and costs.
- 10. The Trustee has received a proof of claim from the CRA stating that there are amounts owing to CRA for unpaid source deductions (\$154,744.25), which are subject to deem trust rules.
- 11. As well, the Trustee has received multiple proof of claims that were submitted by former employees of the Company. Accordingly, those claims might be entitled to a super-priority in accordance with Section 81.3 of the *Act*.

12. A listing of the creditors and the claims received up to the First Meeting of Creditors is attached as Appendix "A" and is summarized below:

VALUATION OF ASSETS AND ANTICIPATED REALIZATION

- 13. The Company's assets consist of inventory and equipment that were used as part of the Company's operations (the "Assets"). Per the Company's Statement of Affairs (Form 78) that was included in the Notice of Bankruptcy sent to the Company's creditors, the value of the Assets was estimated to be in the amount of approximately \$2,250,000.
- 14. Given that all of the Assets are subject to the claim of the secured creditor that was awarded a judgment against the Company in an amount that exceeds the estimated realizable value of the Assets, the Trustee does not anticipate that there will be a dividend to the unsecured creditors.

TRANSFERS AT UNDERVALUE/PREFERENTIAL PAYMENTS

15. The Trustee is currently reviewing the books and records of the Company to determine if the Company conducted any transactions that would be considered a transfer undervalue or a preferential payment, as defined under the *Act*. The Trustee will report to the creditors/inspectors at a later date.

LEGAL PROCEEDINGS

16. As of the date of this report, the Trustee was aware of the following legal proceedings (vs Oasis) that were in effect as of the Filing Date:

- i. Chriscwe Holdings Inc.
- ii. Shunock Dentistry Professional Corporation
- iii. Mid Star Logistics

CONSERVATORY AND PROTECTIVE MEASURES

17. The Trustee has not applied conservatory and protective measures with respect to the estate of the bankrupt.

CARRYING ON BUSINESS

18. Since the Filing Date, the Trustee has not carried on the business of the bankrupt.

OTHER MATTERS

- 19. The Trustee will be seeking directions from the creditors on the following matters:
 - a. affirmation of the appointment of the Trustee;
 - approval of all the Trustee's actions to date, including the actions outlined in this Preliminary Report;
 - c. appointment of inspectors (if applicable); and
 - d. any other matters which may arise at this First Meeting of Creditors.
