**ON READING** the Company’s motion record, the third report of Crowe Soberman Inc. in its capacity as proposal trustee of the Company (in such capacity, the “**Proposal Trustee**”), dated June 21, 2022 (the “**Third Report**”), and on hearing the submissions of counsel for the Company, counsel for the Proposal Trustee, and such other counsel present as may appear on the counsel slip, no one else appearing although duly served as appears from the affidavit of service filed:

## **SERVICE**

1. **THIS COURT ORDERS** that the time and manner of service of the motion record and factum for this motion and the Third Report are hereby respectively abridged and validated such that this motion is properly returnable today.

## **APPROVAL OF INTERIM DISTRIBUTION**

2. **THIS COURT ORDERS** that the Proposal Trustee is hereby authorized to make distributions to Toronto Dominion Bank (“**TD**”), from time to time and from available funds, on account of the Company’s obligations to TD in respect of which no creditor of the Company ranks in priority to TD, the whole as the Proposal Trustee, in its discretion, deems appropriate.

## **APPROVAL OF PROPOSAL TRUSTEE’S REPORTS AND ACTIVITIES**

3. **THIS COURT ORDERS** that the Proposal Trustee’s first report dated March 8, 2022, second report dated May 4, 2022, and third report dated June 21, 2022, as well as the activities of the Proposal Trustee described therein, be and are hereby approved, provided, however, that only (i) the Proposal Trustee and (ii) Crowe Soberman Inc. in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

**EXTENSION OF TIME TO FILE A PROPOSAL**

4. **THIS COURT ORDERS** that the time for a proposal to be filed on behalf of the Company is extended to August 11, 2022 pursuant to section 50.4(9) of the *Bankruptcy and Insolvency Act*.
