#### **Independent Practitioner's Review Engagement Report**

To the partners of Green Earth Environmental Products

We have reviewed the accompanying balance sheet of Green Earth Environmental Products as at September 30, 2018 that comprise the balance sheet as at September 30, 2018, and the statements of loss, partners' deficiency and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statement

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for private enterprises, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Conclusion



Without qualifying our conclusion, we draw attention to Note 2 in the financial statements which indicates that the Company incurred a net loss of \$787,229 during the year ended September 30, 2018 and, as of that date, the Company's current liabilities exceeded its current assets by \$2,028,902. These conditions, along with other matters as set forth in Note 2, indicate the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern.

Notes to the financial statements September 30, 2018 (Unaudited)

#### 1. Description of the business

Green Earth Environmental Products (the "Partnership") is a retailer with several mall locations. It receives warehousing, purchasing and other administrative functions from Green Earth Stores Ltd., an affiliate with common ownership.

#### 2. Going concern

The financial statements were prepared on a going concern basis. The going concern basis assumes that the Partnership will continue to operate for the foreseeable future and will be able to realize its assets and discharge its liabilities and commitments in the normal course of business.

At September 30, 2018, there exists a material uncertainty that may cast significant doubt on the Partnership's ability to continue as a going concern. During the year ended September 30, 2018, the Partnership had a net loss of \$787,229, negative cash flow from operations of \$630,915, negative working capital of \$2,028,902 and cash on hand of \$615,626.

Historically the Partnership has had operating losses and working capital deficiencies. Whether, and when, the Partnership can attain profitability and generate positive cash flows from operations is uncertain. The Partnership is also uncertain as to whether it can obtain financing to meet its current obligations. These uncertainties may cast significant doubt upon the Partnership's ability to continue as a going concern. The Partnership will need to raise capital in order to fund its operations. This need may be adversely impacted by uncertain market conditions. To address its financing requirements, the Partnership is currently investigating restructuring plans for the upcoming year to help identify where they can reduce expenses in order to increase overall profitability. The outcome of these matters cannot be predicted at this time.

If the going concern assumption were not appropriate for these financial statements, adjustments would be necessary in the carrying value of assets and liabilities, the reported net loss and the balance sheet classifications used.

#### 3. Significant accounting policies

The financial statements have been prepared in accordance with Canadian accounting standards for private enterprises and reflect the following significant accounting policies:

#### Financial instruments

Financial assets and financial liabilities are initially recognized at fair value when the Partnership becomes a party to the contractual provisions of the financial instrument. Subsequently, all financial instruments are measured at amortized cost except for the following:

- Investments in unlisted shares, which are measured at cost less any reduction for impairment;
- b) Investments in listed shares and derivative financial instruments that are not designated in a qualifying hedging relationship are measured at fair value at the balance sheet date. The fair value of listed shares is based on quoted bid prices while the fair value of the derivative financial instruments is based on fair value confirmation received from the banker with whom those instruments are negotiated. Fair value fluctuations including interest earned, interest accrued, gains and losses realized on disposal and unrealized gains and losses are included in other income.

Interest earned on short-term investments and bonds, dividends received on unlisted shares, unrealized gains and losses on listed shares, and realized gains and losses on sales of short-term investments and bonds are included in other income in the statement of loss.

#### 3. Significant accounting policies (continued)

#### Financial instruments (continued)

Transaction costs related to financial instruments measured subsequent to initial recognition at fair value are expensed as incurred. Transaction costs related to other financial instruments are added to the carrying value of the asset or netted against the carrying value of the liability and are then recognized over the expected life of the instrument using the effective interest method. Any premium or discount related to an instrument measured at amortized cost is amortized over the expected life of the item using the effective interest method and recognized in net earnings as interest income or expense.

With respect to financial assets measured at cost or amortized cost, the Partnership recognizes an impairment loss, if any, in net earnings when there are indicators of impairment and it determines that a significant adverse change has occurred during the period in the expected timing or amount of future cash flows. When the extent of impairment of a previously writtendown asset decreases and the decrease can be related to an event occurring after the impairment was recognized, the previously recognized impairment loss is reversed to net earnings in the period the reversal occurs.

#### Property, plant and equipment

Property, plant and equipment are recorded at cost. Amortization is based on their estimated useful life using the methods and rates or term:

#### Impairment of long-lived assets

Long-lived assets such as property, plant and equipment are tested for recoverability whenever events or changes in circumstances indicate that their carrying amount may not be recoverable. An impairment loss is recognized when their carrying value exceeds the total undiscounted cash flows expected from the use and eventual disposition of the item. The amount of the impairment loss is determined as the excess of the carrying value of the asset over its fair value at the date of impairment.

#### Income taxes

The financial statements do not reflect any income taxes since the taxable income of the Partnership is includable in the income tax returns of the partners.

#### Revenue recognition

The Partnership recognizes revenue when persuasive evidence of an arrangement exists, delivery has occurred, the price to the buyer is fixed or determinable and collection is reasonably assured.

The Partnership recognizes the investments transactions on a trade date basis. Realized gains and losses from investment transactions are calculated on an average cost basis. Distribution income is recorded on the ex-distribution date. Interest income is recorded on an accrual basis. Dividend income is recorded when received. Distributions from investments that are treated as

#### Lease inducements

Costs related to leasehold improvements and rebates given are recognized in the balance sheet as lease inducements and amortized on a straight-line basis over the term of the operating lease to which they relate.

#### Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for private enterprises requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Key components of the financial statements requiring management to make estimates include the useful lives of long-lived assets and the appropriateness of the use of the going concern assumption. Actual results could differ from these estimates.

#### Foreign currency translation

Monetary assets and liabilities denominated in foreign currencies are translated at the exchange rates in effect at the balance sheet date. Non-monetary assets and liabilities are translated at historical rates. Revenues and expenses are translated at average rates. Translation gains or losses are included in earnings.

#### 6. Credit facilities

The credit facilities of the Partnership consist of the following:

- 1) \$100,000 revolving demand facility by way of a) RBP based loans bearing interest at prime rate plus 0.50% per annum; b) Letters of Credit in Canadian currency, or US currency, of which \$100,000 remained unused at September 30, 2018.
- 2) \$500,000 non-revolving term facility by way of RBP based loans bearing interest at prime rate plus 0.65% per annum, of which \$500,000 remained unused at September 30, 2018.
- 3) \$500,000 revolving lease line of credit by way of Leases under terms of separate agreements, of which \$500,000 remained unused at September 30, 2018.

All borrowings are secured by the following:

- a) general security agreement with an enabling resolution; RBC to be in first position over all assets;
- b) guarantee and postponement of claim in the amount of \$471,000 signed by Green Earth Stores Ltd.;
- c) guarantee and postponement of claim in the amount of \$1,324,000 signed by Matthew McBride Enterprises Corp.;
- d) postponement and assignment of claim signed by Matthew McBride Enterprise Corp.;
- e) guarantee and postponement of claim in the amount of \$1,324,000 signed by Beckstette Enterprises Corp.;
- f) postponement and assignment of claim signed by Beckstette Enterprises Corp.; and
- g) guarantee and postponement of in the amount of \$600,000 signed by Green Earth Stores Ltd.

#### 7. Contingencies

#### 10. Financial instruments
