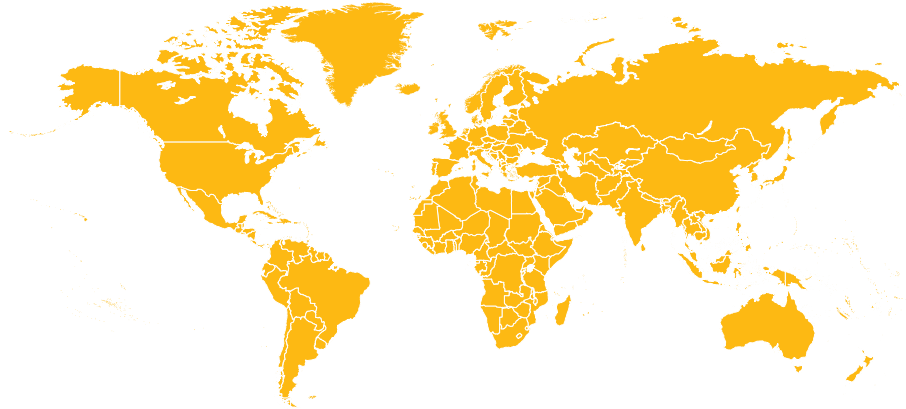

one of the top ten global accounting networks. The organization has around 4,000 partners in 833 offices, generating revenues of approximately USD 5.3 billion.

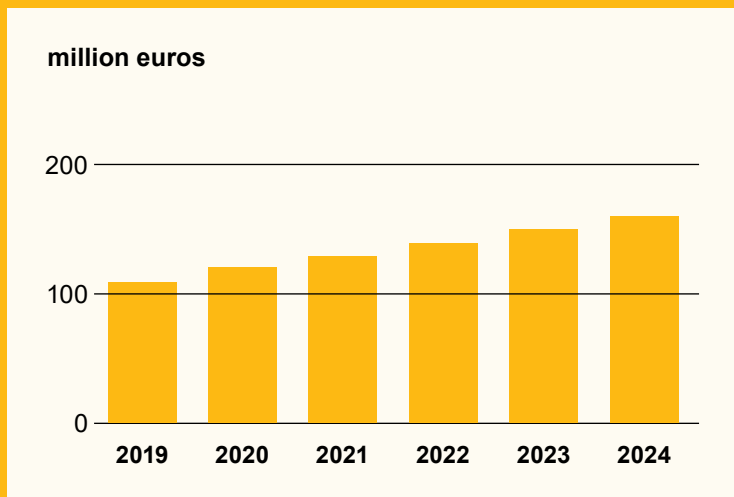
