- Charles started his career in public accounting in 1974 and practised under the sole proprietorship of Charles W D Chan & Co. in 1980. In 1999 the firm practised under a limited company of Charles Chan, Ip & Fung CPA Limited. In October 2009, the company joined a global accounting network as its member firm in Hong Kong and formed Crowe Horwath (HK) CPA Limited, marking a new milestone in business development. The company was renamed as Crowe (HK) CPA Limited in 2018 following rebrand of the accounting network as "Crowe".
- With over 40 years' experience, Charles' CPA practice has expanded to cover a comprehensive range of services including audit and IPO, taxation and trust, IT audit and data security, company secretarial, mergers and acquisitions, internal control and business & property valuation services.
