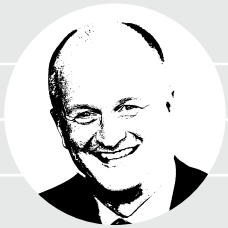

Our Structure

Crowe Global is an international network of independently owned and managed accounting and advisory firms that are licensed to use the “Crowe” brand in connection with the provision of accounting, auditing, tax, advisory and other professional services to their clients.

Crowe Global is commercially organized under the laws of Switzerland as a Verein (Association) and is a non-practicing entity, and does not provide professional services in its own right. Crowe Global is wholly owned by its member firms. Crowe Global operates through a wholly owned subsidiary incorporated under the laws of the State of New York in the United States of America where it is headquartered.

Crowe Global is considered a “network” as defined under the Code of Ethics of the International Ethics Standards Board for Accountants (IESBA) and by virtue of its membership of the Forum of Firms.

Crowe Global also licenses Horwath HTL to member firms offering consultancy services in the hotel, tourism and leisure industries.

Leadership, Governance and Management

The Board of Directors (“Board”) is responsible for the governance of Crowe Global. The Board is charged with overseeing the activities of the network, including setting strategy and policy. The Board is made up of individuals representing member firms in Crowe Global, as well as the Chief Executive Officer.

The Management Committee operates according to the responsibilities and authority that is delegated to it by the Board and oversees the daily management of the network’s operations. It consists of the Chief Executive Officer, Chief Operating Officer, the network’s regional executives, the network’s International Accounting & Audit and International Tax Directors.

The International Accounting & Audit Committee, the International Tax Committee and the GCA (Global Corporate Advisors) Committee support the delivery of professional services by member firms of Crowe Global. The membership of the Committees comprise senior practice leaders who collaborate to develop and share practice resources, lead seminars and other information sharing activities, and manage practice development initiatives.

The International Accounting & Audit Committee and the International Tax Committee oversee quality assurance programs that uphold standards and promote best practices in their disciplines. The International Accounting & Audit Committee has a pivotal role in maintaining audit quality with responsibility for setting audit methodology and other audit-related policies across the network.

Technical Quality

Strategic Purpose & Vision

One of our strategic initiatives is to enable an environment focused on excellence and leadership. We set high standards of member firms requiring them to commit to the utmost quality standards. To achieve that quality member firms invest significantly in their people. A Member of the Forum of Firms

Crowe Global is a full member of the Forum of Firms. The Forum of Firms is an association of networks of international accounting firms that perform transnational audits. The objective of the Forum is to promote consistent and high quality standards of financial reporting and auditing practices worldwide. As a member, Crowe Global is required to implement and monitor quality control standards that the Forum has prepared. We prepare an annual declaration that our members adhere to the Forum's standards.

The Transnational Auditors Committee of the International Federation of Accountants governs the Forum of Firms. The International Accounting & Audit Director of Crowe Global is an elected member of the Committee and is the Chair of the Forum's Agenda Committee.

Ethical Standards

Member firms of Crowe Global should have policies and methodologies that allow them to perform audit services in conformity with applicable ethical standards. Member firms have policies and methodologies for the conduct of cross-border audit engagements that conform to the International Ethics Standards Board for Accountants Code of Ethics for Professional Accountants ("the Code"), as well as applicable national codes of ethics.

Individual Crowe Global member firms should be independent of the audit clients of other member firms.

Crowe Global provides support to member firms in complying with the international Code's independence provisions and minimising the risk of a conflict of interest arising.

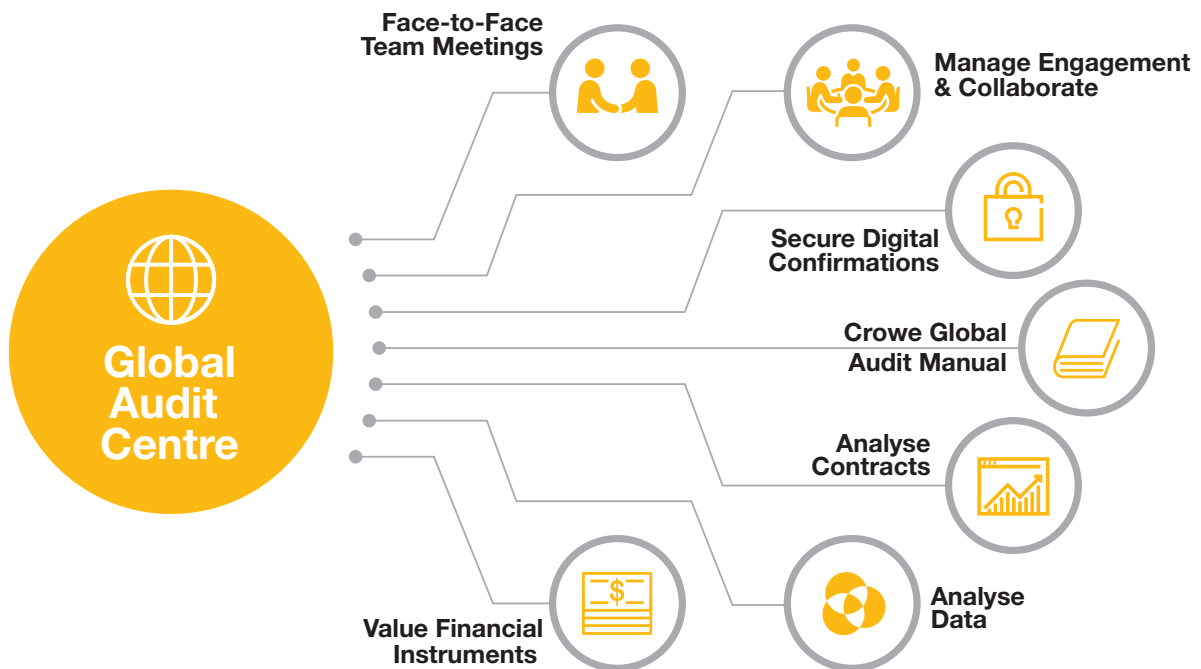
Crowe Global Audit Centre

The new Crowe Global Audit Centre comprises forward thinking innovative audit applications and an adaptable audit methodology that complies with the International Standards on Auditing issued by the International Audit & Assurance Standards Board. Audit is a global service, with global standards, and requires global collaboration between regulators and application developers who are delivering global solutions. The Audit Centre is Crowe Global’s contribution to delivering a consistent quality cross-border audit that provides the client with confidence and valuable feedback.

Technology is critical to the Audit Centre. As an international network, Crowe Global is positioned to identify innovative developers of audit applications and adapt these to work with the Crowe Global audit methodology. The Audit Centre includes secure Cloud collaboration resources, data applications and innovative testing applications that together facilitate effective working between member firms and clients, and deliver robust audit evidence.

The member firms of Crowe Global are committed to the continuous development of the Crowe Global Audit Centre to incorporate changing technologies and standards, meaning that clients and their stakeholders can be confident with the quality of the assurance that they receive.

The Crowe Global Audit Centre comprises resources and applications and can be represented as follows:





Audit Practice Review

Rigorous review procedures are required to ensure that practice and quality standards are adhered to. Crowe Global has an established Quality Assurance Review (“QAR”) process led by the International Accounting & Audit Director. All member firms receive periodic reviews of their audit practice, usually on a three-year cycle. Firms applying to join Crowe Global receive a New Member Review. The International Accounting & Audit Director selects reviewers from partners of member firms and the network’s accounting and audit staff. Reviews are performed using an approach that reflects global best practice.

“QARs have always been an invaluable source of constructive feedback on our audit quality and a great avenue for the sharing of quality measures and best practices amongst the key economic regions and globally.

During our recent QAR, we have been engaged in good discussions on some of the challenges faced by our firm with the reviewer, who has in turn provided practical recommendations on ways to improve both firm-level quality controls and engagement quality controls.

The QAR is an important testimony to our regulators, our clients and our people on the importance that the Firm’s leadership attaches to quality control and quality management. We also value the opportunity to keep informed of the latest developments on ethics, auditing & accounting updates as well as on the latest technology tools being used.”

The review is an opportunity to share experiences, best practices, and apply professional standards. The review process involves consideration of the following:

- The results of and response to external monitoring by oversight bodies;
- The findings and follow up actions from the firm's internal monitoring;
- The design and operation of the firm's quality control policies and procedures;
- The firm's approach to the performance of audit engagements; and
- The review of completed audit engagements.

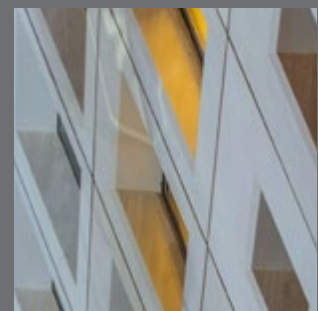
The review provides a useful forum to discuss forthcoming developments in regulations and standards and the implications of these developments for the firm. After the review, the firm receives an individual report letter, including the agreed actions from the review. Presentations are regularly given at Crowe Global events to share the overall themes and lessons from QARs with the aim of promoting continuous improvement in audit quality.

“The QAR struck an appropriate balance between inspecting assurance engagement files and providing an incredible opportunity to learn from other network firms.

The quality of assurance engagement files was always at the forefront of the review and meaningful suggestions and recommendations were presented for consideration and discussion.

However, the experience did not end there as the review included robust discussions of best practices and provided a forum to collaborate and share information with other network firms. The QAR was much more than a ‘compliance’ review – it was an opportunity to improve business processes.”
