## 2018 Irish hotel sector briefing

As a follow-up to the launch of the Crowe 2018 Irish Hotel Survey, the firm hosted a joint hotel sector briefing with Cushman & Wakefield at the beginning of October in the Conrad Hotel. Partner Aiden Murphy addressed over 180 industry guests, outlining the trading environment for the hotel sector while Cushman & Wakefield gave an overview on hotel development and transactions. JP Kavanagh, General Manager of The Shelbourne, was guest speaker.

Aiden warned that the next three years will be a period of adjustment for the Dublin hotel sector, as demand continues to grow, but the concentrated delivery of new supply will have an impact on profit levels. Following seven years of solid profit growth in the Dublin market, hoteliers need to be mindful of this new dynamic and plan accordingly by setting rates, forward-selling inventory and being patient while the market absorbs the new supply.
