Five key changes introduced by EU General Data Protection Regulations (GDPR)

GDPR replaces all previous Data Protection Acts & Regulations across the EU. It was approved in April 2016 and comes into effect in May 2018. In Ireland it replaces the current legislation – the Data Protection Acts 1988 and 2003 – and brings in a large number of changes, meaning that the level of effort in preparing for GDPR compliance is significant. The Charities Act 2009 ("the Act") contains eight sections – sections 47 to 54 – that address financial recording and reporting matters for charities. Sections 48 to 52 of the Act require regulation to be made by the Minister for Justice and Equality. In late 2016, the Charities Regulator, issued the Draft Charities (Accounting and Reporting) Regulations 2016.
