Global Tax Advisers Platform (GTAP)

CFE Tax Advisers Europe together with the Asia-Oceania Tax Consultants' Association ("AOTCA") and the West African Union of Tax Institutes ("WAUTI"), established GTAP in 2018.

GTAP is an international platform, representing more than 600,000 tax advisers in Europe, Asia and Africa, that seeks to bring together national and international organizations of tax professionals from all around the world. The principal aim of GTAP is to promote taxpayer and tax advisers' interests by ensuring the fair and efficient operation of the global tax framework, including recognition of the rights and interests of taxpayers, and the role of tax professionals.

A strategic framework was designed to promote the vision/mission of the GTAP. Due to the fact that the GTAP includes members of different jurisdictions in the world it will be a privileged forum to ensure the desired inclusiveness and consistency on the implementation of the measures to counteract tax evasion and fraud and to improve current tax rules.

During his Presidency of CFE Tax Advisers Europe, Piergiorgio worked actively for the launch and expansion of the GTAP. Three Associations joined the project in 2018 (i.e., International Association of Financial Executives; A.M.A. Association of Mediterranean Auditors and STEP Society of Trust and Estate Practitioners) and more expressed their interest in joining.
