



Introduction




Many of you would have heard of the **Special Voluntary Disclosure Program (SVDP)**. It is a special program to incentivize taxpayers who have under-reported tax, to voluntarily disclose their income now. Under this program, the penalty rates are significantly reduced compared to those applicable to tax audits and investigations.

What has transpired since then and how successful has the program been? We are glad to bring you some highlights of this program and our experience in dealing with the Inland Revenue Board (IRB) on this matter.

Number of countries involved in AEOI

The Automatic Exchange of Information ("AEOI") facilitates access to bank account information of individuals and companies by tax authorities in more than 100 countries

Number of SVDP letters sent by IRB

Since SVDP was introduced in November 2018, a total of 8.3 million letters / emails had been sent by the IRB to taxpayers on the SVDP

Targeted tax collection by IRB

The estimated tax revenue to be collected under the SVDP is estimated to be RM10 billion to RM20 billion

The IRB targets at least 1 million taxpayers to participate in the SVDP

Actual number of cases submitted

Up to 31 March 2019, there were 381,979 applications that had been submitted to the IRB under the SVDP

Penalty Rates

From 45% to 300% on case by case basis



Until 30 September 2019 only.



SVDP Information subject to audit?

No.

IRBM will accept the voluntarily disclosed information in good faith.

Further reviews will not be made on the reported information.

FAQ on SVDP







Yes, If you:

- are not registered; or
- are registered but have not submitted tax return forms; or
- have submitted return forms but have not reported the correct information; or
- have failed to stamp executed documents.
