

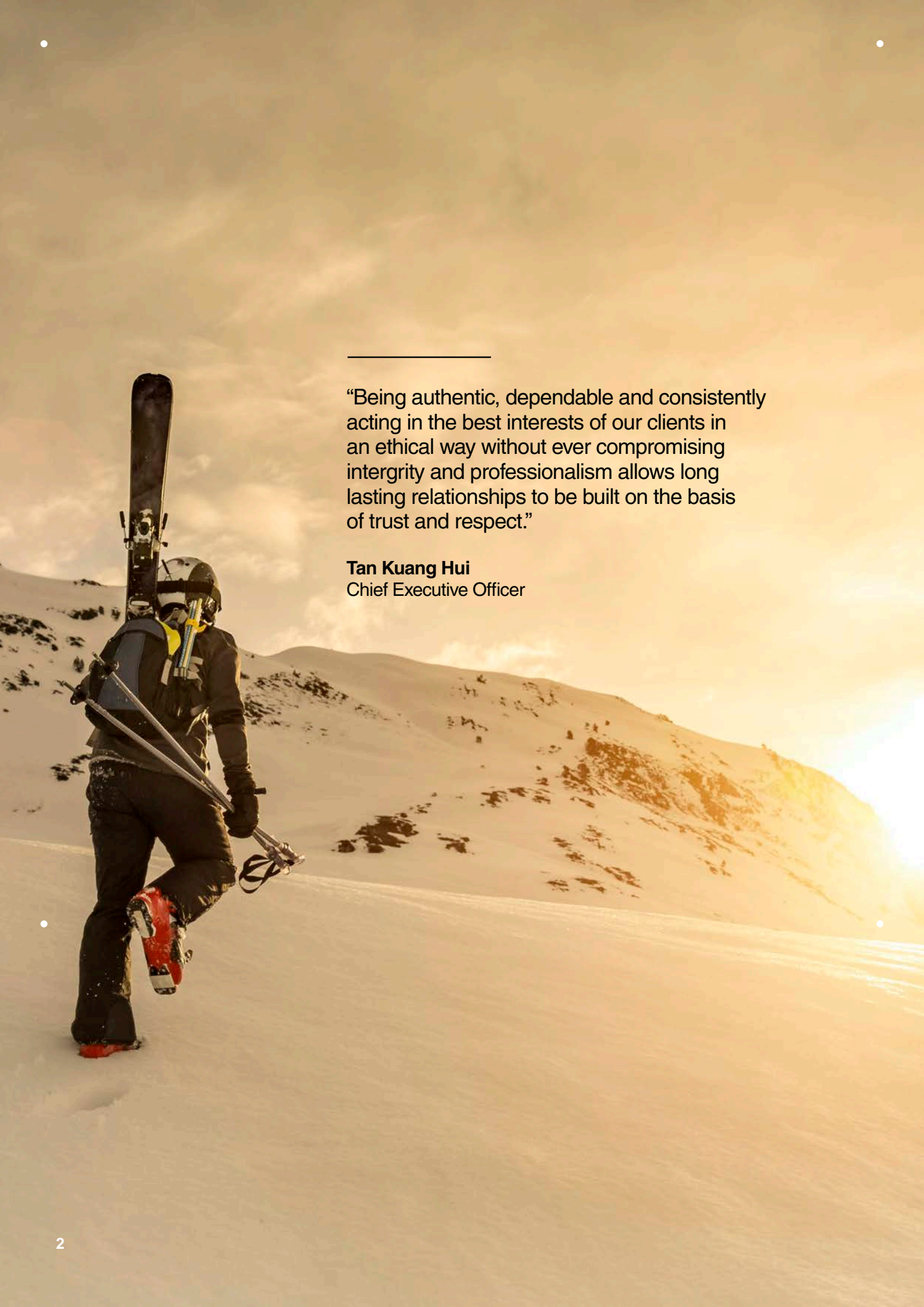

### 2002

The firm was founded as TKH & Company in July 2002. In that same year, the firm secured its first SGX-listed client.

### 2003

Our first IPO client was listed on SGX.

### 2005

The firm underwent its first name change to First Trust Partnership in September 2005.

## Global Reach, Local Expertise.

### 2006

First Trust Partnership was admitted as a member firm of Horwath International in March 2006. The firm was renamed as Horwath First Trust in August 2006.

Horwath First Trust's admittance to the Horwath International network was not the only highlight of the year as the firm was ranked among the Top 3 Singapore IPO Reporting Accountants by the Business Times, Singapore.

### 2009

By 2009, we had overseen more than 10 IPOs in Singapore.

### 2010

Following the rebranding of our network to Crowe Horwath in 2010, the firm changed its name to Crowe Horwath First Trust LLP, in accordance with a single global brand.

## A Decade of Trust.

### 2012

We celebrated a decade in service.  
We also started our CSR Program.

### 2013

The firm's revenue exceeded SGD  
10 Million in 2013.

That same year, we were accredited  
as an Approved Training Organiza-  
tion by the Singapore Accountancy  
Commission (SAC).

### 2014

By 2014, the firm had more than  
50 public-listed clients.

### 2015

We launched two new services:  
Sustainability Reporting and Fraud  
Investigation & Business Recovery.

### 2016

In 2016, we won the Best Practice Award  
(Large Practice Category), presented by the  
Institute of Singapore Chartered  
Accountants (ISCA).

## Becoming Future-Ready.

---

### 2017

The firm completed the  
acquisition of Partners Capital  
(now known as Crowe  
Horwath Capital), adding to our  
Corporate Finance capabilities.  
It is a registered license holder  
to act as an issue manager for  
Mainboard listing in Singapore.

By the firm's 15<sup>th</sup>  
Anniversary, it had launched 15  
key services.

Crowe Horwath First Trust LLP  
was ranked as the 10<sup>th</sup> Largest ac-  
counting firm in Singapore by the  
Singapore Business Review.

### 2018

In June 2018, the firm's  
network rebranded to Crowe  
Global and all member firms  
formally adopted the name Crowe.

Our Digital Advisory  
Services Group was formed and  
we procured our first ICO advisory  
project.

In September, the firm won the  
Growth Award (Open Category),  
presented by ISCA.
