Sustainability Reporting

Documenting an organisation's environmental, social and governance performance in accordance with GRI, TCFD, and IISSB standards, ensuring transparency and accountability to stakeholders.



Carbon Inventory & Carbon Footprint Computation

Measuring the total greenhouse gas emissions caused directly and indirectly by an organisation, product, or event (including Scope 1, 2 and 3).



Stakeholder Engagement & Materiality Analysis

Engage with stakeholders to identify and prioritise sustainability issues of greatest importance.



Internal Audit

Reviewing and ensuring compliance with sustainability reporting best practices, specifically for entities listed on the Singapore Exchange (SGX).



External Audit

Independent review of an organisation's sustainability practices and reporting. With effect from 2027, Scope 1 and 2 emissions for all SGX listed companies will be required to be subjected to limited assurance audits.

Climate Risk Assessment

Analysing and identifying potential climate risks (i.e. physical and transition risks) that could affect an organisation's operations or investments.



Science-Based Target Setting

Establishing and committing to carbon reduction goals based on scientific data to limit global warming.



Emissions Reduction Strategies

Developing and implementing plans to decrease the amount of greenhouse gases produced by an organisation.



Resource Monitoring Systems

Utilising Internet of Things (IoT) devices to track and manage the use of resources, ensuring efficient consumption.



Net Zero Roadmap Planning

Creating a strategic plan for an organisation to achieve net zero carbon emissions, balancing out the amount of emitted greenhouse gases with an equivalent amount offset.
