AC Crowe Ukraine, an audit firm duly incorporated as a limited liability company and registered under no 33833362 with the Unified State Register of Enterprises and Organizations of Ukraine, has been operating in the Ukrainian market since May 2016, with the registered office at 37 Spaska Street, Kyiv 04070, Ukraine. AC Crowe Ukraine is registered under no 3681 with the Register of Auditors and Auditing Entities.

The Firm's shareholders are:

70% of the Firm's share is owned by individuals that are certified public auditors

30% of the Firm's share belongs to Consulting Venture Group, Ltd.

These days the Firm has taken a new look thanks to the changes in the corporate and legal structure. In 2019, the Firm establishes the offices outlets of AC Crowe Ukraine in the cities of Kharkiv and Odesa. Next, the Firm has grown larger with the two other subsidiaries. One of them is Crowe AVR, entered into the Unified State Register of Enterprises and Organizations of Ukraine (USREOU) under no 32559651, and Crowe Accounting Ukraine, no 43311147 with the USREOU. Both the entities are members of Crowe Global by virtue of the relevant TMCAs (Trademark License and Control Agreements).





Quality Assurance and Independence

Please kindly see the general information on quality assurance by AC Crowe Ukraine

The Firm is aware of its responsibility to a wide range of service users. Such service users are both our existing clients, who request audit and other related services, and investors, regulators, experts and other stakeholders who refer to and/or employ our clients' financial information to meet their respective needs.

Quality is of critical importance to us and, thus, assumes that in the course of auditing we comply with the requirements of the legislation, professional standards, and the requirements of the Code of Ethics for Professional Accountants (Code of Ethics) adopted by the International Standards Board for Accountants. To be more exact, such conceptual framework looks at integrity and safeguards to take relevant measures to avoid circumstances and conduct that may call into question the objectivity of the Firm or its staff.

The respective quality of the audit services may be ensured through the operation of the implemented internal quality control system, which allows the Firm to achieve its aim, i.e. professional services of high quality and proper quality assurance in respect of the below:

- The Firm itself as well as its staff act in compliance with the adopted professional standards, legislative acts and regulations, and the internal instructions.
- The reports, issued by the Firm as resulting from the services rendered, are found true and accurate in accordance with the circumstances.



The Quality Control (QC) system includes the following elements as anticipated by the ISQC 1, International Standard on Quality Control (hereinafter referred to as the IS):

- Leadership responsibilities for quality within the Firm;
- Relevant ethical requirements;
- Acceptance and continuance of client relationships and specific engagements;
- Human Resources;
- Engagement performance;
- Monitoring.

For the purpose of the abovementioned key elements in the QC the Firm has set the respective policies and procedures that aim to meet the designated goals and objectives.

Being a member firm in the international accountancy network of Crowe Global, AC Crowe Ukraine assumes its extra responsibility for its business operation and accepts new challenges. AC Crowe Ukraine welcomes more opportunities to grow, by complying with the requirements of quality standards in relation to performed audit services as required by the local regulations and the law of Ukraine, as well as the relevant International Standards. AC Crowe Ukraine finds it possible to implement the described by means of the methodological support, mutual consulting and monitoring of the Firm's activities on the part of the Network.

Key Elements of Quality Control

Leadership Responsibilities for Quality within AC Crowe Ukraine are seen with segregation of roles and duties and guidance on promoting an internal culture of quality. The Firm appoints a person to be in charge of QC functioning, and among the assigned role and responsibilities is quality assurance and quality review of the engagements performed. The quality review is conducted before the client receives a relevant auditor's report.

Obedience with the relevant ethical requirements is mirrored in the Firm's business to engage the appropriate personnel into an assignment, receive appropriate representations from the staff / personnel, and monitor employees' actions in a context that ensures compliance with integrity, objectivity, professional competence and due diligence, confidentiality and professional conduct.

The Firm's independence and that of the staff/personnel including the senior managers are followed as a prime condition with acceptance and performance of assurance engagements. Such condition is met as ensured by means of:

- Restrictions as to a client's share in relation to the Firm's income (fee cap) обмеженнями щодо частки одного клієнта в доходах Компанії,
- Restricted employment of the clients' staff,
- Rotation and representations by the staff on compliance with the independence polocies and procedures set by the Firm.

The Firm accepts new clients and makes assessment of its independence from the client and that of its staff. The Firm adds to the mentioned procedures an integrity assessment of the new or existing client and the available resources to perform the audit assignment, including the adequate competence and access to the consultation and expertise necessary for the qualitative performance of such assignment.



Given that the Firm provides professional services, AC Crowe Ukraine constantly invests into attraction of, training and monitoring the level of knowledge of its personnel. The Firm's employees are encouraged to grow knowledge and acquire new skills, broaden their competencies in any area related to professional activities. Relevant seminars and trainings conducted by both experienced staff of AC Crowe Ukraine and leading experts or training centres allow for continuous training of auditors and other staff engaged / involved in audit services.

The scope and training areas may cover questions and issues connected with the below:

- · Professional standards,
- Standards of financial reporting,
- · Service best practices,
- Economic regulation,
- International law,
- Automation of audit and accounting processes.

In order to perform engagements, the Firm has established the internal policies and procedures systemized and upgraded on a permanent basis, which allow for complied performance procedure of audit engagements and such of other related services. Next, we are exploring and /or designing new operation methods, including the use of professional software adopted by the Crowe Global network and other international audit teams. Either a person in charge of QC and QA or another authorized person who has not been engaged in the engagement performance (i) sees to whether or not the Firm's personnel comply with the professional standards and internal policies and procedures in the course of an engagement performance, (ii) assures service quality.



Efficiency in Quality Control of Audit Services

Quality Control of audit services by AC Crowe Ukraine is considered efficient and, thus, ensures conformity of services provided to the relevant clients with the requirements set by the Ukrainian legislation and professional standards.

In 2017, AC Crowe Ukraine successfully passed external quality assurance review. Based on the review findings, the Audit Chamber of Ukraine issued Certificate no 0742 (validity through 31 December 2022) to certify conformity of the QC system implemented by the Firm to the audit standards, norms of the auditors' professional ethics as well as the legislative acts and regulations that govern auditing. November 2018 sees AC Crowe Ukraine pass the external QAR with Crowe Global.



Independence

AC Crowe Ukraine has established relevant policies and procedures to address independence issues. Such processes include management of threats to independence and documenting the procedures performed, accounting for the domestic legislation, professional standards and requirements of the Crowe Global network.

In the course of any audit or other assurance engagement, when performing such assignments with and / or conducting a quality assurance review, the Firm studies the existence of threats to independence and assesses identified facts and circumstances. Such assessment links with the Firm itself, its staff, and other auditing firms members of the Crowe Global network. Accordingly, the Firm established a procedure for collecting data on cooperation with clients, introduced relevant documentation and exchange of information necessary to assess respective facts and circumstances that may doubt its independence. The staff and experts engaged into the assurance assignments provide confirmation of their independence at the time of their appointment and at the time of engagement completion. In addition, all the Firm's personnel provide annual confirmation of their independence in the form of independence representation in regard of the Firm's clients.

Procedures performed in the course of cooperation approval in connection with new clients and consideration of the possibility of accepting new assignments from the existing clients aim at preventing relationships that are prohibited by the Ukrainian legislation and / or the Code of Ethics of Professional Accountants, approved by the International Standards Board for Accountants.

In the course of quality review of each assignment / engagement, the responsible person conducts a mandatory verification of compliance with the established procedures.

Partners

The Firm's internal standards require the rotation of the partner and other employees who make key decisions or judgments on important issues in the assignments for the statutory audit of financial statements. Such change / substitute is mandatory in case the person may have been engaged in services to a relevant client for seven consecutive years. The break in the performance / execution of the assignment is for a period of at least three years.

AC Crowe Ukraine has developed a policy of continuous appraisal of individual partners and employees under the KPI system.

Relevant performance indicators are used to determine the level of rewards and bonuses, career growth and credibility within the Firm. Appraisal is conducted on a periodic basis, in the form and content defined by the Firm's policy. The remuneration of key partners and auditors of the Firm consists of two components – (a) fixed, and (b) variable.

The fixed component of remuneration corresponds to the level of basic salary in accordance with the civil law or labor contracts (agreements) concluded, and salary payments occur on a regular basis in accordance with the domestic labor legislation.

The variable part of the remuneration is calculated taken the results of the reporting year and depends on the Firm's earnings for a certain period in terms of engagements performed by the key partners and pro rata distributed among the participants respective of participation in the project.

Network Legal Framework

Crowe Global is a commercially established Association in accordance with the Swiss law. It is not a practicing legal entity to provide professional services independently. Crowe Global is in full ownership of the firms its members. Crowe Global operates through a 100% owned subsidiary incorporated in compliance with the laws of New York State in the USA, where headquartered. Crowe Global is referred to as the Network as anticipated by and described in the Code of Ethics by the International Ethics Standards Board for Accountants (IESBA) and by virtue of membership in the Forum of Firms.

Network Management

The Board of Directors (Board) takes full responsibility for management of Crowe Global.

The Board is entrusted with the supervision of the activities in the Network, including the definition of strategy and general policy. The Board consists of individuals representing member firms from Crowe Global, except for the Executive Director - this post is elective.

The Management Committee acts in accordance with the duties and powers delegated to it by the Board and controls the day-to-day management of the network. It consists of Chief Executive Officer, Chief Operating Officer, Regional Network Managers, International Accounting and Audit Director, and International Tax Director.

International Standards for Crowe Global Members

The vision of Crowe Global is to create a global network of firms covering a common brand recognized by national and international organizations that require audit, tax and advisory services. The presence of influential firms in influential markets is a critical factor in the success of our vision. It undoubtedly means that member firms should allocate resources and provide timely and quality service for international business. The firms are expected to invest in the future for growth, reliability of quality standards, and methodology for creating a Crowe Global profile in their jurisdictions.

Membership Standards

Independence Standards

The member firms of Crowe Global should follow a line of conduct and methodology that allows them to perform audit services in accordance with due national ethics and independent standards. Members Firms should possess standards and methodologies for conducting transnational audits that are consistent with national, international standards and the requirements of the Code of Ethics for Professional Accountants adopted by the International Accounting Standards Board. Certain Crowe Global member firms should be independent from auditing clients of other member firms. Crowe Global provides support to member firms while respecting the provisions of the International Code's independence.


Membership in Forum of Firms



Crowe Global is a member of the Forum of Firms. Forum of Firms is an association of networks of international accounting firms that carry out transnational audits. The purpose of the Forum is to promote consistent and high-quality standards of financial reporting and audit practices worldwide. As its Member Crowe Global is committed to implementation and supervision of compliance with the quality control standards designed by the Forum. The network prepares an annual declaration that the member firms comply with the Forum's standards.

The Committee of Transnational Auditors of the International Federation of Accountants is in charge to regulate the Forum of Firms. The Crowe Global International Accounting and Audit Director is a member of the Committee.





Trainings and Development

AC Crowe Ukraine pays a great deal of attention to the continuous training and development of the Firm's employees as growth of the Firm depends on its people. 
