Tax Resolution services

We advise on HMRC investigations, voluntary tax disclosures and tax disputes with a view to mitigating penalties and finding cost effective solutions to bring clients' affairs up to date.

Tax Resolution services

Penalties will always be considered whenever HMRC establishes there has been a loss of tax. We help our clients reduce the penalties they face by exploring mitigating circumstances and ensuring that HMRC is applying statutory rules correctly. We have successfully argued reasonable excuse on numerous occasions, which has resulted in HMRC accepting that a 0% penalty is due.

Our award winning team is accessible and approachable. We explain the issues in plain language and ensure our clients understand what needs to be done to resolve their tax issues with HMRC.

Contractual Disclosure Facility (CDF) and HMRC Code of Practice 9 (COP9)

The CDF is the civil (as opposed to criminal) investigation of suspected tax fraud. If HMRC invites taxpayers to use it, they have 60 days to accept the offer to participate and submit a valid outline disclosure, or to reject the offer if they deny committing tax fraud. Taxpayers who use the CDF will get immunity from prosecution in exchange for helping HMRC calculate the understated tax.

Our specialists can help navigate your clients through the process with a view to minimising the final settlement and help them to move forward and draw a line in the sand.

Worldwide Disclosure Facility

HMRC has put increased focus into ensuring tax on overseas assets is correctly declared by UK taxpayers.

This is a complex area given the substantial Failure to Correct penalties that apply (a minimum of 100% of the lost tax) and extended number of years HMRC can assess. The WDF can be used as a mechanism to make voluntary and prompted disclosures.

Our experienced team can help your clients with making a full disclosure and advise on penalty mitigation.

Let Property Campaign

HMRC receives vast amounts of data that enables it to identify landlords who have not paid tax on rental property profits and capital disposals. Voluntary disclosure is recommended as it is only a matter of time before HMRC makes contact, which ultimately leads to higher penalties. Our specialists can help ensure a full disclosure is being made to prevent HMRC challenges and reduce penalties.

HMRC Code of Practice 8 (COP8)

COP8 is used by HMRC in complex cases where there has been significant loss of tax revenue but fraud is not suspected. Our experts can review the issues, advise your clients on their rights and obligations and help them finalise matters with HMRC.

HMRC Enquiries

Such enquiries can be wide-ranging, resulting in formal demands for data, penalties, assessments, and visits to business premises. We can ensure HMRC is not over-stepping the mark and act on your client's behalf to bring matters to an end.

Other services

There are many other aspects we can help with such as tax disputes, criminal investigations, furlough inaccuracies, expert witness or negligence claims on tax matters, and accelerated payment/ follower notices.

Company Voluntary Arrangements



Where individuals with financial difficulties can enter the IVA process, we can help put this into place so that they can avoid bankruptcy, which benefits both your clients and their creditors.




