

How becoming an **Authorised Economic Operator** can enhance your business

Over 1,200 UK registered companies have gained Authorised Economic Operator (AEO) status since the inception of the program in 2008.

There are 3 types of AEO certification available:

- AEO Customs Simplification (AEOC) focuses on customs compliance, record keeping, financial solvency and level of practical competence.
- AEO Security and Safety (AEOS) reviews measures and controls in place to ensure your part of the supply chain is secure.
- AEOF (Full) = AEOC + AEOS

Financial benefits

Ability to gain a waiver for the financial guarantee required for your Duty Deferment Account.



Fewer physical and documentbased controls, priority treatment for customs controls and faster application processes.

Improved reputation and relationships with customers & customs authorities can give you a competitive advantage.

Trust

Be a trusted link in the supply chain with an internationally recognised accreditation, and gain the status as a safe business partner.

Next steps to take

- Any size business can apply, as long as you're a legal entity, established in GB/NI, actively involved in customs operations and international trade, and have an EORI number.
- You will be informed whether your application has been accepted for processing within 30 days, but it can take a further 120 days for validation checks and an authorisation audit to be carried out by an HMRC officer.
