# **Budget Snapshots** Personal Tax Rates

To quote the Minister of Finance "No major tax proposals in this Budget".

The rates of tax for all persons other than companies and close corporations but including deceased estates and "special" trusts for the year ended 29 February 2024 **have been adjusted as compared to the previous year** and will be as follows:

The tax thresholds (i.e. levels of taxable income below which no tax is payable) will be as follows:

	2024	2023
Under 65 years at the end of the tax year	R95 750	R91 250
65 years and over	R148 217	R141 250
75 years and over	R165 689	R157 900

Because of the interest income exemption, each person over the age of 65 but younger than 75 can earn annual income (including interest of at least R34 500) of R182 717 (was R175 750) without being liable for income tax at all. For those 75 and over with at least R34 500 of interest income, the tax free income limit is R200 189 (was R192 400).
